Use of Face Masks	Staff and Pupils	Spread of Infection	<ul> <li>All Pupils in year 7 (which would be children who were aged 11 on 31 August 2020) must wear face masks when moving around the academy premises in communal areas and corridors wherer social distance cannot be met.</li> <li>Face Masks should also be worn in classrooms or during activities unless 2M social distancing can be maintained. This does not apply in situations where wearing a face covering would impact on the ability to take part in exercise or strenuous activity, for example in PE lessons.</li> <li>Staff must wear face masks when moving around the premises, outside of classrooms, such as in corridors and communal areas where 2M social distancing cannot easily be maintained.</li> <li>Staff must wear face masks when holding internal staff meetings at 2M social distancing cannot be met</li> <li>Staff must wear face masks when meeting with parents on site and a 2M distance cannot be met</li> <li>Face coverings do not need to be worn by pupils when outdoors on the Academy premises.</li> <li>Those who rely on visual signals for communication, or communicate with or provide support to such individuals, are currently exempt from any requirement to wear face masks in the academy or in public places.</li> </ul>	HIGH	YES





			<ul> <li>Face visors or shields should not be worn as an alternative to face coverings. They</li> <li>may protect against droplet spread in specific circumstances but are unlikely to be effective in reducing aerosol transmission when used without an additional face mask worn at the same time. They should only be used after carrying out a risk assessment for the specific situation and should always be cleaned appropriately.</li> <li>Exemptions from Wearing Face masks</li> <li>Some individuals are exempt from wearing face coverings. This applies to those who:</li> </ul>		
			<ul> <li>cannot put on, wear, or remove a face covering because of a physical impairment or disability, illness, or mental health difficulties.</li> <li>speak to or provide help to someone who relies on lip reading, clear sound or facial expression to communicate.</li> </ul>		
Safe wearing and Removal of Face Masks	Children	Spread of Infection	<ul> <li>Safe wearing of face masks requires the cleaning or sanitising of hands before and after touching, this includes to remove or put them on.</li> <li>safe storage of Face masks in individual, sealable plastic bags between use</li> <li>Disposable bags will be provided to contain reusable masks.</li> <li>Where a face covering becomes damp, it should not be worn, and the face covering should be replaced carefully.</li> </ul>	HIGH	YES

Staff receiving LFT Tests at home	Staff	Risk of infection	<ul> <li>All schools should offer regular twice weekly testing to their staff and to carry out LFT at home.</li> <li>Testing is not mandatory for staff and they do not need to provide proof of a negative test result to attend school, although participation in testing is strongly encouraged.</li> <li>Anyone with a positive result will be required to stay at or if already on site go home immediately.</li> </ul>	HIGH	YES





			<ul> <li>The person is required to isolate for 10 days from the date of the positive LFT (with the test date being day 0). The legal duty to self-isolate is triggered by a positive LFT. It is also necessary for the setting to isolate any close contacts of the case for the 48 hours prior to the LFT test being conducted. This is in-line with the guidance for all other sectors of the community and NHS Test and Trace guidelines</li> </ul>			
Staff receiving LFD Tests at home	Staff	Risk of infection	<ul> <li>Anyone with a positive result will need to take a confirmatory Polymerase Chain Reaction test,</li> <li>If the confirmatory PCR test is positive, the person is required to continue to isolate for the 10 day period. If the confirmatory PCR test is negative, the person can end isolation and return to their normal routine.</li> <li>It is necessary for the setting to isolate close contacts of the case for the 48 hours prior to the LFT being conducted. A negative PCR would allow the close contacts to end isolation so we would advise that the wording used allows this is be an option.</li> <li>Should the person go on to develop symptoms during the isolation period, the isolation period will restart from the first day symptoms appear.</li> </ul>	HIGH	Yes	
Testing Staff who have recently returned after a positive result	Staff	False Positives	<ul> <li>If staff have recently (within 90 days) tested positive for COVID-19, they are likely to have developed some immunity.</li> <li>These people are exempt from testing by both PCR and LFT within 90 days of a positive test, unless they develop new symptoms.</li> </ul>	HIGH	Yes	





			<ul> <li>However, they may choose to take a LFT after the isolation period. If found positive on LFT, they will be required to self-isolate for 10 days or longer if symptomatic. This should only be done after completion of the required self-isolation period</li> <li>A new LFT must not be taken whilst the person is still within a period of isolation. If symptoms (other than cough or a loss of, or change in, your normal sense of taste or smell) persist for longer than 10 days, this isolation period could be longer.</li> <li>Further PCR tests, within 90 days of a positive test result, should only be obtained where the person develops a new incidence of symptoms.</li> </ul>			
Classroom set up	Staff Children	Spread of Infection due to close contact	<ul> <li>The teacher's desk will be kept 2 metres away from the children's tables/desks.</li> <li>Each Class room will be set up with all desks facing forward to ensure no pupil sits face to face or directly breathe on each other</li> <li>Pupils should wear face masks wear 2M distance cannot be maintained.</li> <li>All excess furniture to be removed and stored on site in a container</li> <li>Soft furnished furniture to be removed and replaced with Plastic alternatives.</li> <li>Tissues available around the rooms for pupils to use when coughing or sneezing and they must go into a closed lid bin after one use.</li> </ul>	HIGH	YES

Classroom Lessons	Staff Children	Spread of Infection due to close contact	<ul> <li>Teaching staff must keep that safe distance at all times where possible when teaching.</li> <li>Where children may require extra assistance a 2-metre rule must try to be enforced.</li> <li>Where 2 metre rules cannot be met Staff members Must wear a face mask and also have the option to use the full PPE available to them (visors, masks, gloves, apron)</li> <li>Hand sanitiser in every classroom and must be used every time a pupil leaves and enters the room</li> </ul>	HIGH	YES





	<ul> <li>Pupils to bring their own stationary and keep this on them at all times and not to share items.</li> <li>Academy to provide a pre-prepared pencil case of stationary for any pupil who needs this. The pupil will then own this stationary and keep on their person at all times.</li> <li>Tissues available on every desk in classrooms for pupils to use when coughing or sneezing and they must go into a closed lid bin after one use.</li> <li>Classroom based resources, such as books and games, can be used and shared within the bubble group; these must be cleaned regularly</li> </ul>
